UNEMPLOYMENT INSURANCE

HB 1018 by Rep. Jim Nickels was defeated by a vote of 8-10 in the House Public Health, Welfare and Labor Committee yesterday. We opposed this bill that would increase the maximum potential unemployment benefits in a benefit year from 25 to 26 times the worker's weekly benefit amount.

EMINENT DOMAIN

HB 1192 by Rep. Kim Hammer would prohibit improvement districts from using the power of eminent domain to acquire lands or rights-of-way for their use. It received a Do Pass

recommendation from the House Judiciary Committee yesterday and will likely be considered by the full House next week.

INDEPENDENT CONTRACTOR STATUS

HB 1259by Rep. Robert Dale provides that persons working as independent contractors for an employer are "employees" and persons who report to IRS money paid to an independent contractor are "employers" for purposes of the Division of State New Hire Registry. I have received a number of comments about this bill and have expressed your concerns to Rep. Dale. At this point, Rep. Dale
